REACHING UNDOCUMENTED MIGRANTS (RUM) PROJECT¹ END OF ACTION REPORT



ABOUT THE PROJECT

The project developed **evidence-based tools and processes** to enhance **outreach practices** targeting undocumented migrants in Europe. It facilitated comprehensive data collection and analysis on this vulnerable group, that culminated in an **interactive dashboard** that displays profiles, needs, and migration intentions of 1,000 migrants in Belgium and France. Additionally, the project promoted **peer exchanges** among national authorities through initiatives such as field study visits and roundtable discussions. These activities produced a programmatic blueprint and country-specific reports highlighting best outreach practices. To further support informed policymaking, the project conducted **focus group sessions**, interviews, and internal mapping exercises, leading to the development of a policy brief that examines the diversity of initiatives, actors, and practices in this field. A **monitoring and evaluation framework** was also created for frontline workers, aimed at improving accessibility to voluntary return options. Lastly, the project delivered a **hands-on training module** focused on outreach and counseling with undocumented migrants experiencing mental health challenges and harmful substance use issues.
